STUDENT CODE OF CONDUCT AND DISCIPLINARY PROCEDURE

2025- 2026

The Management of Manipal Academy of Higher Education, Dubai Campus respects and protects the individual dignity, integrity and reputation of all its stakeholders. All students must comply with the conventions and regulations of the institution that are necessary to maintain order, protect the individual and property, and fulfill the purpose and responsibilities of the institution.

Students enrolling in the institution assume an obligation to conduct themselves in a manner compatible with the institution's function as an educational institution. The code of conduct represents the institution's responsibility for maintaining order within the institution and emphasizes educating the students about their rights and responsibilities as members of the institution.

The student code of conduct is applicable to all students enrolled at the University. The code of conduct is applicable to all students on Campus and off-Campus owing to their status as students at the University.

As a student at the University, you are expected to behave according to the following standards:

- i. Adhere to dress code on the campus (during any academic, cultural, social or sport activities) in a manner that is respectful of themselves, the University and the community that they are in.
- ii. Always maintain a record of good conduct and behavior.
- iii. Respect all religions and beliefs. Refrain from acting in any manner offensive to the religious and cultural sentiments of others.
- iv. Treat other people with respect, and respect other people's personal space, physical/ intellectual property, and private information.
- v. Treat others with consideration and empathy, act in a manner to keep yourself and others safe.
- vi. Act in a manner that supports the work of the University and upholds its reputation.
- vii. Students shall abide by all applicable laws and rules of the UAE and shall refrain from committing any act that may affect their standing as respectable members of an educational institution and the community.

Behavior regarded as misconduct includes but not limited to:

- i. Disregarding University rules and procedures.
- ii. Damaging, defacing, trespassing on or misusing University property, systems or information whether deliberately or recklessly.
- iii. Obtaining/or disseminating materials infringing copyrights such as software, pornography materials and accessing other prohibited sites; Uploading audio visual material in public domain concerning the University or any of its officials, without prior permission of the concerned authorities.
- iv. Carrying and consumption of food items into the classrooms/labs/library/activity rooms.
- v. Littering on the institution's premises including classrooms and washrooms.
- vi. Use of any audio and communication devices including radios, CD players and mobile phones in the classrooms; unauthorized recording of learning activity or any student activity/ rehearsal (except with prior permission as applicable)
- vii. Issue of wallpapers, posters & logos, e-mails / SMS and holding meetings/seminars, distribution of bulletins, slogan shouting, use of loudspeaker, or any other act deemed or feared to be against the general regulations.

- viii. Any unlawful sit-in or use of the academia premises for activities not allowed by the institution.
- ix. Use of color to splash on someone at University/ Dubai International Academic City premises.
- x. Bursting of firecrackers.
- xi. Public Display of Affection; sexually intimate behavior at University/ Dubai International Academic City premises and transport provided by the University.
- xii. Endangering the safety of the students, faculty, staff and visitors at the University Campus, including acquiring, possessing, displaying, manufacturing or carrying any sort of arms or other material that may affect others' safety inside the University and means of transportation.
- xiii. Consumption of and/or possession of alcohol, or any prohibited drugs / substances on university premises or within Halls of Residence.
- xiv. Smoking cigarettes (only made of tobacco)/E-cigarettes in non-designated areas on the campus. (Federal Law No:15 of 2009 regarding Tobacco control).
- xv. Harassment, intimidation or bullying can take many forms including: slurs, rumors, jokes, innuendo's, demeaning comments, drawing cartoons, pranks, gestures, physical attacks, threats, or other written, oral or physical actions. "Intentional acts" refers to the individual's choice to engage in the act rather than the ultimate impact of the action(s).
- xvi. Inconsiderate or inappropriate use of vehicles, including inconsiderate parking, tailgating into the car park and vehicle noise.

Violation of the above rules will lead to strict disciplinary action as deemed fit by the institution. Following misconduct towards fellow students, faculty and staff will not be tolerated at the Campus and can lead to immediate suspension/ expulsion

- i. **Ragging** includes any conduct by a student, whether by words spoken or written or by an act which includes physical abuse, lewd acts, teasing, rough or rude treatment, indulging in rowdy, indiscipline and obscene activities which causes or is likely to cause annoyance, undue hardship, physical or psychological harm or mental trauma or raise apprehension or fear in a fresher / junior student or other students or forcing a student to do any act which such a student is not willing to do and which has the effect of causing or generating a sense of shame or embarrassment or danger to a student's life or adversely affect the physique or psyche of a fresher or a junior student.

Any incident of ragging must be reported to the below faculty members assigned in your respective Schools and / or the Office of Student Affairs:

- ii. **Bullying** is a form of abuse. It comprises repeated acts over time that involve a real or perceived imbalance of power with the more powerful individual or group abusing those who are less powerful. This includes and is not limited to name calling, making fun of the person, spreading rumors about a person, and participating in initiation rituals.
- iii. **Sexual Harassment** includes anyone or more of the following unwelcome acts or behavior (whether directly or by implication), namely:
 - a) Physical contact or advances - Intimate contact without consent i.e. kissing, touching
 - b) A demand or request for sexual favors.
 - c) Bullying behaviors (physical or non-physical) are based on a person's sexuality or gender, directly, indirectly, or online.
 - d) Sharing sexualized materials of another person (whether fully naked or not) without consent, directly, indirectly or online.
 - e) Any other unwelcome physical, verbal or non-verbal conduct of a sexual nature including indecent public exposure (flashing)

Disciplinary Procedure & Penal Actions

Students are required to comply with the rules, regulations, policies and student code of conduct always as specified by the institution. In the event of failure to comply, the institution will implement a disciplinary procedure. Please refer to **Schedule 1** for the category of misconduct and the penal actions indicated. This will be used only as a guideline. The Management will use its discretion considering the circumstances of each misconduct and vary by the penal actions as deemed appropriate.

Disciplinary procedure

Minor Misconduct:

The student found to be in violation of conduct classified as minor misconduct will be imposed a warning by the Head of Student Affairs/faculty member or staff.

An e-mail will be sent to the student with a copy to the parent, the Program Coordinator/Chairperson by the Head of Student Affairs.

The remedy and the course of action in case of a repeat of misconduct will be specified.

The student found to be in violation of conduct classified as minor misconduct repeatedly will be issued a fine on discussion with the Program Coordinator/ Chairperson and the Head of Student Affairs.

An e-mail will be sent to the student with a copy to the parent, the Program Coordinator/Chairperson by the Head of Student Affairs.

The remedy and the course of action in case of repeated misconduct will be specified.

Gross Misconduct:

The student found to be in violation of conduct classified as gross misconduct will be dealt with by a Disciplinary Committee.

The details of the incident will be shared with the Head of Student Affairs. Relevant information and evidence will be gathered by the Head of Student Affairs.

The report will be shared with the Academic President who will institute a Disciplinary Committee.

The details of the allegations will be shared with the student and allowed to respond to them on the day of the Disciplinary Hearing.

The student will be given 1 working days' notice at the Disciplinary Hearing.

At the Disciplinary Hearing, the student will be given the opportunity to present their version of the incident and the evidence if any.

The allegations will be probed and discussed by the Committee.

The recommendation of the Disciplinary Committee will be shared with the Academic President. Disciplinary and Penal action is finalized by the Academic President.

Penal Action is communicated by the Head of Student Affairs to the student(s) alleged of misconduct, and the parent is also informed.

A scan copy of this letter will be sent via e-mail to the student with a copy to the parent, the Program Coordinator/ Chairperson / Head Student Affairs/ members of the Disciplinary Committee.

The remedy and the course of action in case of a repeat of misconduct will be specified as applicable.


Right of Appeal

- i. Students convicted of any misconduct/ offence under these regulations have the right to lodge an appeal by a written request to the Academic President within seven days after the date on which the verdict was rendered.
- ii. The appeal will only be accepted if made on one of the following grounds
 - Procedural irregularities
 - Presenting new evidence
 - Inconsistency of the decision
- iii. The appeal will be considered by a committee as set up by the Academic President.

Academic President will call for hearing within 5 working days and processes the appeal. Post the review by the Committee and recommendation, the Academic President will finalize the decision. Office of Student Affairs communicates the decision to the grievant through email / hard copy within another 3 working days.

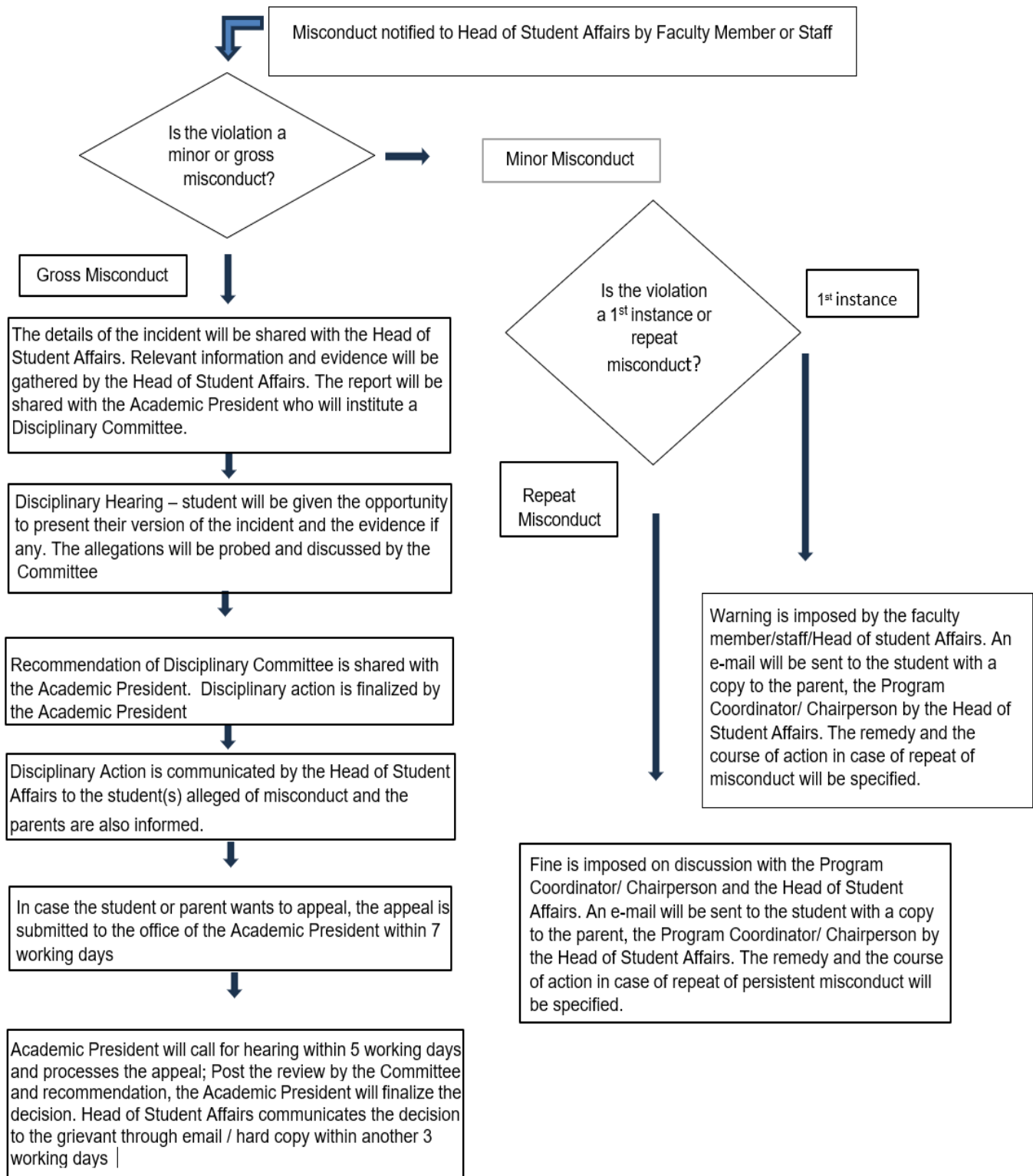
